#### First: Study problem and its importance:

In our modern life, voluntary work has become an approach that requires certain abilities & skills. Thus volunteers must acquire their practical applications and let them be familiar. The culture of volunteerism has become an indispensable part of the culture of advanced societies, with the whole system of values, principles, ethics, standards, symbols and practices which urge to initiation and affirmative action.

Hence, it became clear that there's an urgent need to activate the vital role of women in practicing the various forms and types of voluntary work. # Fifth: Methodological procedures of the study:

**\-Study type**: This study belongs to the empirical studies.

**<sup>Y</sup>-Used approach:** According to the type and nature of this study, the empirical approach is used.

**<sup>•</sup>-Study Tools:** Scale of Voluntary Work Skills of women at civil associations.

#### <sup>£</sup>-Study Domains:

<u>a)Spatial Domain</u>: "Young Muslim Women's Association" proclamation No. ( $\circ \circ$ ) on  $\circ \circ \circ \circ \circ \circ$  AL-MASHTAL district – FAYOUM.

<u>b)Human Domain</u>: A group of members of the general assembly, the number of women in this group is  $(1, \cdot)$  women whom the researcher used as an experimental group and a control group at the same time.

<u>c)Time Domain</u>: The time domain of this study is specified during the period of performing the experiment which took four months (from  $1/1 \cdot 7 \cdot 7$  to  $\tau \cdot 7/1/7 \cdot 7$  AD). By two meetings per week (Saturday & Tuesday every week) the duration of each meeting is one hour & a half.

### Sixth: Field Study Findings:

This study reached a group of findings, the most important of which is the validity of the main hypothesis of the study.

There is a statistically significant relationship between the usage of "focusing on tasks model" in Social Group Work Method and promoting voluntary skills of women at Civil Associations.
