First: Study Problem & Importance:

One of the most prominent factors that lead to family problems is the conflict of roles that creeps to family life. This is clear in the disaffection of one of the couple (wife or husband) or both towards their new life. When the wife refuses to give up the life style she got used to in her life before marriage; this is considered as the first step towards a lot of problems that arouse when the wife deserts her husband's house to her family house escaping from the obligations and burdens of the role she assumes and her inability to bear social responsibility. Accordingly, the importance lies in social responsibility development in those ladies proceeding to marriage.

Group discussion technique in the method of Social Group Work may have an outstanding role in the development of social responsibility in those ladies proceeding to marriage and need to develop their knowledge of their rights and duties as wives as well as developing their knowledge of the husband's rights and duties and developing their knowledge of their children's rights. In addition, they need to acquire these skills and experience that enable them to assume their roles and responsibilities as wives considering that the wife is first responsible for the stability and continuity of familial life. Accordingly, this study problem has been identified in the significant question: Does the use of group discussion within the method of Social Group Work lead to the development of social responsibility in those ladies proceeding to marriage?

- ". There is a positive statistically-significant relationship between the use of group discussion within the method of Social Group Work and the development of the awareness of those ladies proceeding to marriage concerning common rights and duties between the couple (husband and wife).
- ٤. There is a positive statistically-significant relationship between the use of group discussion within the method of Social Group Work and the development of the awareness of those ladies proceeding to marriage concerning children's rights.
- •. There is a positive statistically-significant relationship between the use of group discussion within the method of Social Group Work and acquiring those ladies proceeding to marriage some social skills that help in the success of marriage life.
