Introduction:

In light of economic and social developments taking place in the communities, especially the Egyptian society led to the occurrence of many family problems and that the most important problems of family disputes between the couple and that arise from the presence of the absence of agreement between them so he gives up one or both of the matrimonial home until it comes to the Disputes Settlement Family Court family.

The text of Law No. (10) for the year 2004, Article (5) that every family court inside an office or more to settle family disputes are functions to receive and work on the problem resolved between the couple though not converts it to the family court to settle them.

And office work that a number of social workers who practice the methods and tactics of the way the individual work to work on the settlement of family disputes. And then came the goal of this study was to evaluate the role of the social worker to work with individual cases settle family disputes offices in order to reach a general framework for professional practice to serve the individual in the light of recent trends in the offices of the settlement of family disputes.

First: the problem of the study:

Family disputes considered fertile ground for the work of the individual work specialist at the offices of the settlement of family disputes because it uses the knowledge, skills and professional techniques and strategies of many due to the diversity of these conflicts. Third: The importance of the study:

1 - The family is the basic unit that make up the community. Because of the vulnerability of the family for many family problems as a result of the global and local changes and led to some of the bugs in family functions, this study contributes in the development of some of the solutions to some family problems.

2 - This study examines the role of social worker calendar to work with individual cases the offices of the settlement of family disputes, in order to determine the strengths and weaknesses of professional practice to serve the individual and contribute to a better form of professional practice and increase the effectiveness of those offices.

3 - Trsdhzh study the current reality of the role of social worker in one of the most important areas of social work, as measured by including accomplished one of the important ministries in Egypt, the Ministry of Social Affairs in this area in general and in the field of family problems and social work of family in particular, and the number of specialists who work directly in the this area, compared to the number of them specialists in themes.

Areas of study: -

(A) the human sphere:

Determines the field of human depending on the objectives of the study and its questions and methodology used. We define the human sphere of this study are as follows:

- 1 - All social workers working to settle family disputes offices in Fayoum governorate. And numbered (28) social worker distributors to Bandar Fayoum center and Center Ibshway and Tamiya Center and Center Sinnuras, Etsa center.
- 2 - each of the could see him researcher of visitors to settle family disputes offices in Fayoum governorate for a period of two consecutive weeks and numbered (110) spread Bandar Fayoum center and Center Ibshway and Tamiya Center and Center Sinnuras, Etsa center.
- 3 - all the social experts to settle family disputes offices in Fayoum governorate. And numbered (12) experts socially distributed Bandar Fayoum center and Center Ibshway and Tamiya Center and Center Sinnuras, Etsa center.

(B) the spatial domain of the study:

Due to the nature of the study and applied to all social workers involved with the settlement of family disputes offices in Fayoum governorate. Represents the spatial domain to study in (6) Family Disputes Settlement Bureau Fayoum governorate level:
