#### EXECUTIVE SUMMARY

No doubt that the case of poverty is one of the most important cases in Egypt which increased dramatically after privatization and Economic Open Door Policy and in turn decreased role of the Egyptian Government in the economy life. This led to the decrease in support and selling the public sector companies which came to an additional negative result by increasing the poverty of poor people. At the same time, the efforts of the government and voluntary societies began to decrease. This, in fact, led to seeking for using strategies, modules and approaches to lower the severity of poverty and to achieve sustainable development.

Coordination, cooperation and integration between the governmental, public and private sectors should be achieved to accomplish a real and effective social and economic development. This could be conducted via drawing integrated and unified developmental plans using the unified approach for the development of local society among representatives of these sectors. In fact, this will achieve a development that has different dimensions (social, educational, cultural.....etc.) taking into consideration political changes dominant in the society. #### **Study Results:**

The study concluded that the use of unified approach in planning increased the effectiveness of developmental programs and projects introduced to poor people in random living areas. The study, thus, achieved its objectives and its hypotheses have been verified.
