## Renewal of Arabic Syntax between Ibn Midaa and Ibn Rushd: A Comparative Critical Analytical Study

## Summary of the Study

The current study consists of an introduction, a preface, three chapters, and a conclusion, as follows:

The introduction addresses the title of the study, its problem, its objectives, previous studies, the study's methodology, and its chapertization.

The preface presents the curriculum vitae of Ibn Mada and Ibn Rushd, and their two books; The Response to Grammarians by Ibn Mada. and The Necessary in the Making of Grammar by Ibn Rushd. The preface consists of two sections. The first section is dedicated to Ibn Mada' al-Qurtubi. and his book: "The Response to Grammarians". Whereas the second section deals with Ibn Rushd al-Hafld. and his book: "The Necessary in the Making of Grammar."

The first chapter is entitled "Features of grammatical renewal according to Ibn Muda: An analytical study". It discusses the features of Ibn Muda'a's grammatical innovation, and the new opinions and his theories regarding grammatical analysis.

The second chapter is entitled "Features of grammatical renewal according to Ibn Rushd: An analytical study". It focused on studying Ibn Rushd's grammatical renewal, and the new opinions and theories he added related to teaching grammar and analyzing its structures.

The third chapter is entitled: "The Balance between (Ibn Madha) and (Ibn Rushd): A critical grammatical study." It is based on a comparison between (Ibn Madhaa) and (Ibn Rushd), and an explanation of the aspects of agreement, difference, or influence of one of them on the other, the extent of the influence of each of them on the scientific grammatical movement, and the value of each one s' work.
